



# The Joint Commission Accreditation Ambulatory Care 2015 Fees

## Diagnostic/Therapeutic for Imaging Centers

Joint Commission accreditation fees are based on a combination of an on-site survey fee billed during the year of the organization's on-site survey and an annual fee billed in January of each year during an organization's accreditation cycle. Approximately 60% of the organization's total accreditation fees are due during the year of the on-site survey.

This document is a tool for your organization to calculate the estimated total fees, including the on-site survey fee and annual fees, for a 3-year period.

### Important items to note when estimating your fees:

- 1 **This is not an official estimate.** Fee estimates are based on current published pricing and information about services and service volume provided by your organization. Changes to any of these factors as provided in your organization's application for survey may result in a change in your organization's on-site or annual fees.
- 2 Initial applicants must submit a non-transferable, non-refundable, deposit of \$1,700 with the application for survey. This deposit is applied to any accreditation fees billed to the organization until the deposit is exhausted. Credit card payments are also accepted for deposit. - 3 A pro-rated annual fee is billed at the beginning of the quarter after which an initial application is received.
