





Top Scored Measurable Elements (ME) for JCI Accreditation Standards for Hospitals, 6th Edition



The April 2019 issue of JCInsight identified the top scored measurable elements for the Joint Commission International Accreditation Standards for Hospitals and Academic Medical Centers (AMC), 6th edition for surveys conducted in 2018. The frequently cited measurable element in eighth place was PCI.7ME1 “The hospital follows professional practice guidelines for sterilization techniques that best fit the type of

situations for sterilization and devices and supplies being sterilized.” Improper cleaning and sterilization has been shown as a major risk for the transmission of infection. Sterilization is defined as a validated process used to render a product free of all forms of viable microorganisms. Devices that must be sterilized are devices that contact sterile tissue or the vascular system and are classified as critical devices by the Spaulding Classification. Examples of equipment requiring sterilization are surgical instruments, dental instruments, implants, and cardiac catheters.




