Our stroke certification offerings

Our comprehensive portfolio of stroke certifications meets the customized needs of every type of hospital within your system. Each certification program recognizes an organization's distinct achievement in delivering evidence-based care. Certification is your organization's commitment to continuous performance improvement, providing high-quality patient care and reducing risks. Stroke Certification options are evaluated under the Disease-Specific Care Certification manual and have three main components: standards, clinical practice guidelines, and performance measurement. This structure provides a framework for consistency of care to improve patient outcomes.

The Joint Commission offers four advanced levels of certification for stroke programs for hospitals:

- **Comprehensive Stroke Center (CSC) Certification**
- **Thrombectomy-Capable Stroke Center (TSC) Certification**
- **Primary Stroke Center (PSC) Certification**
- **Acute Stroke Ready Hospital (ASRH) Certification**

The Joint Commission also offers a core stroke certification for rehabilitation hospitals.

Certifications to meet the specific needs of your health care facility

The Joint Commission provides stroke program certification in the following health care settings:

- Academic/Teaching Hospitals
- Community Hospitals
- Critical Access/Rural Hospitals
- Free Standing Emergency Centers

General Eligibility

- Meet the requirements for Disease-Specific Care Certification

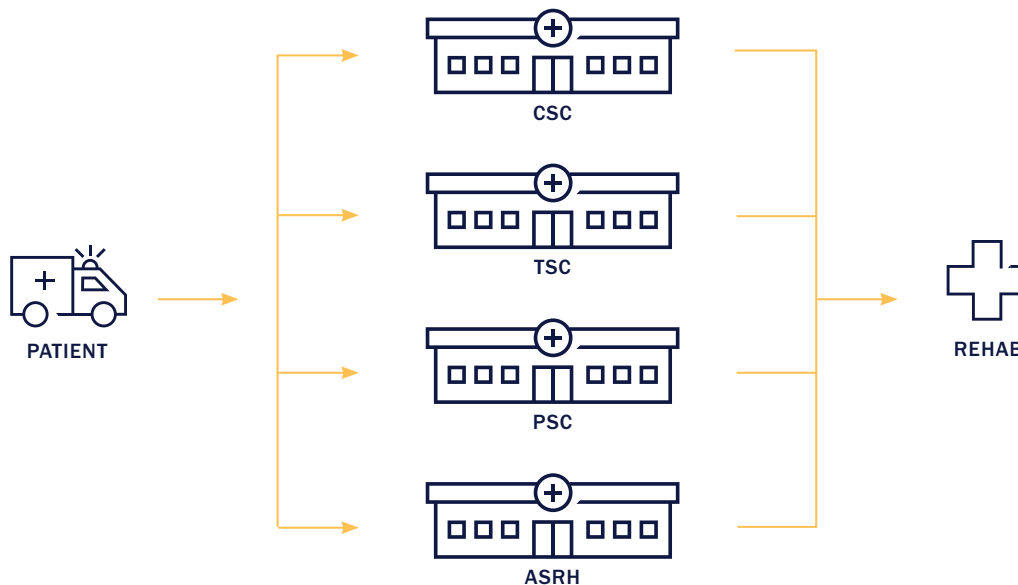
- A formal interdisciplinary program structure
- Utilizes evidence-based clinical practice guidelines
- A formal approach to collecting, analyzing and interpreting performance measures
- Serve a minimum of 10 patients prior to an initial certification review
- Part of a hospital that is compliant with applicable federal laws, including Medicare Conditions of Participation

National standards.

Demonstrating compliance with The Joint Commission's national standards and performance measurement expectations may help obtain contracts from employers and purchasers concerned with controlling costs and improving productivity.



- **Comprehensive Stroke Center (CSC) Certification** is the most demanding certification and is designed for those hospitals that have specific abilities to receive and treat the most complex stroke cases.
- **Thrombectomy-Capable Stroke Center (TSC) Certification** is designed for hospitals providing endovascular procedures and post-procedural care.
- **Primary Stroke Center (PSC) Certification** is designed for hospitals providing the critical elements to achieve long-term success in improving outcomes.
- **Acute Stroke Ready Hospital (ASRH) Certification** is for hospitals or emergency centers with a dedicated stroke-focused program.



Comprehensive Stroke Center Certification

Featured certifications

With the guidance of the Brain Attack Coalition's Recommendations for the Establishment of Comprehensive Stroke Centers, The Joint Commission in collaboration with the American Heart Association/American Stroke Association (AHA/ASA) offers an Advanced Certification for Comprehensive Stroke Centers; those hospitals that have specific abilities to receive and treat the most complex stroke cases.

The goal of establishing this level of certification is to recognize the significant differences in resources, staff and training that are necessary for the treatment of complex stroke cases. And as EMS routing protocols dictate where patients will be taken, the most complicated cases can be treated at the centers best equipped to provide the specialized care that can lead to better outcomes.

CSC GUIDELINES

Eligibility

Must be able to demonstrate care for the following patients:

- 20 subarachnoid hemorrhage by aneurysm per year
- 15 endovascular coiling or surgical clippings per year for aneurysm
- 25 IV thrombolytics eligible patients per year

Standards & Guidelines

- Uses advanced Disease-Specific Care standards and additional expectations for transitions of care
- Organization chooses and implements clinical practice guidelines

Key Requirements

- Acute stroke team available 24/7
- Dedicated neurointensive care unit beds for complex stroke patients 24/7
- Comprehensive diagnostic services
- Ability to meet concurrent needs for two complex stroke patients 24/7
- Neurosurgical services available 24/7
- On-site coverage for NICU by neurospecialist
- Participation in patient-centered research that is approved by an Institutional Review Board
- Tracking, monitoring, and reporting of performance measures

Thrombectomy-Capable Stroke Center Certification

Featured certifications



The Joint Commission's Thrombectomy-Capable Stroke Center Certification recognizes centers that perform endovascular thrombectomy procedures. The Joint Commission in collaboration with the AHA/ASA is offering this new advanced stroke certification in response to the need to identify hospitals that meet rigorous standards for performing endovascular thrombectomy (EVT) and providing post-procedural care.

This addition to our stroke portfolio was developed because recent studies have shown the efficacy of mechanical thrombectomy for large vessel occlusive ischemic strokes and for the best patient outcomes, it is important to have a diverse network of stroke-certified hospitals, so patients can get to the right location as soon as possible.



TSC GUIDELINES

Eligibility

In order to be eligible for TSC certification, an organization must have performed mechanical thrombectomy and post-procedure care for at least 15 patients with ischemic stroke in the past 12 months or at least 30 patients over the past 24 months.

- Acute stroke team available 24/7
- Neurologist* accessible 24/7 via in person or telemedicine
- Designated stroke beds
- Sufficient diagnostic services
- Ability to provide IV thrombolytics
- Tracking, monitoring, and reporting of performance measures

- Organization chooses and implements clinical practice guidelines

Acute Stroke Ready Hospital Certification is offered in collaboration with the AHA/ASA and is based on the Brain Attack Coalition's Recommendations for the Establishment of Acute Stroke Ready Hospitals. Acute Stroke Ready Hospital certification fulfills a community need within a stroke system of care.

ASRH GUIDELINES

Eligibility & Key Requirements

- Acute stroke team available 24/7
- Neurologist accessible 24/7 via in person or telemedicine
- Diagnostic services
- Telemedicine within 20 minutes of it being necessary
- Ability to provide IV thrombolytics
- Tracking, monitoring, and reporting of performance measures

Stroke rehabilitation

Core certifications

Our core certifications help create a baseline of consistent excellence upon which you can build a care delivery framework to positively impact patient outcomes. These foundational programs encompass three main components—standards, clinical practice guidelines, and performance measurement.

Stroke Rehabilitation Certification is a foundational Disease-Specific Care Certification and must meet core standards under the Disease-Specific Care Certification manual.

Eligibility & Requirements

To be eligible for core certifications, programs must:

- Be located in the United States, operated by the U.S. government, or operated under a charter of the U.S. Congress
- Be provided within a Joint Commission–accredited organization when the organization is eligible for accreditation
- Have served a minimum of 10 patients at the time it submits its application
- Use a standardized method of delivering clinical care based on clinical practice guidelines and/or evidence-based practice
- Use performance measurement to improve its performance over time.
