*For 2018, a listed eCQM vendor’s technology must be certified by an Office of the National Coordinator for Health Information Technology Authorized Certification Body (ONC-ACB) as meeting the 2014 or 2015 Edition certification criteria for importing and calculating (c.2), and electronically submitting (c.3) inpatient electronic clinical quality measures (eCQMs). The Joint Commission is adopting CMS’ Hospital Inpatient Quality Reporting program requirements for electronic submission of 2018 discharge data, by only accepting data consistent with the May 2017 posting date for 2018 eCQM specifications, the September 2017 addendum and any future addendums as posted on the CMS website.

Vendor understands that The Joint Commission eCQM verification process is separate and distinct from the ONC certification process and agrees that all Vendor marketing and other vehicles of communication concerning Vendor’s participation in and subsequent successful completion of the Joint Commission eCQM verification process will be communicated in such a way so as not to confuse the HCO’s on Vendor status.

** Candidate Vendor – this denotes a vendor going through The Joint Commission’s evaluation process to become a listed ORYX eCQM vendor. The evaluation process entails multiple steps and the vendor remains in candidate status until a contract is signed.
