	Environment of Care®	Fosters a safe, functional and effective environment for residents, staff, and other individuals in the organization
4	Emergency Management	Offers disaster preparedness guidelines to identify and mitigate risks that could impact resident care, treatment, and services
<u> </u>	Human Resources	Addresses ability to establish and verify staff qualifications, provide training and resources and evaluate staff competence and performance
25.55	Infection Prevention and Control (IC)	Outlines the activities necessary to establish and operate an effective infection prevention and control program
10,5 20,5	Information Management	Addresses how the provider obtains, manages, protects, and uses information to provide, coordinate, and integrate services
	Leadership	Reviews the structure and relationships that impact a culture of safety and quality and operational performance of staff
	Life Safety	Covers requirements for ongoing maintenance of building safety
	Medication Management	Addresses the handling, storage, and safe management of medications
	National Patient Safety Goals®	Reviews the specific actions organizations are expected to take in order to address prevalent safety issues
	Provision of Care	Addresses key activities around planning care, implementing care, and transitions in care
	Performance Improvement	Focuses on use of data to monitor performance and identify improvement opportunities
	Record of Care	Covers the documentation of items in resident records
	Rights of Individual	Reviews informed consent, receiving information, participating in decision making, and services provided to respect resident rights
Ŕ	Waived Testing	For CLIA-approved laboratory testing, offers guidelines for waived testing activities
